ELIGIBILITY: - Restricted to ACU registered members of clubs affiliated to the Yorkshire Centre. All riders and passengers must hold a current ACU Trials Registration /Membership or a SACU licence or ACU/SACU rider's licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident Insurance.

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 solos and TSR 8.

CLASSES: - Championship: - route is open to Expert, Intermediate & Novice

Clubman A: - route is open to Over 45 Experts, Over 45 Intermediate & Novice

Clubman B: - route is open to Novice.

Teams: - Consisting of 3 riders. These may be riders of any grade but the team status will be determined by the highest graded rider.
